ORDINANCE NO. 539-13

AN ORDINANCE REPLACING ORDINANCE # 491-11 (10-10-2011) ESTABLISHING STOP SIGNS, YIELD SIGNS, NO PARKING SIGNS, THROUGH STREETS, ONE-WAY STREETS AND UNLOADING ZONE WITHIN THE CORPORATE LIMITS OF THE CITY OF ALTAMONT, EFFINGHAM COUNTY, ILLINOIS AND IMPOSING PENALTIES FOR VIOLATION THEREOF

BE IT ORDAINED BY THE CITY COUNCIL of the City of Altamont, Illinois, as follows:

SECTION I: THROUGH STREETS AND STOP INTERSECTIONS: All vehicles traveling upon the following named streets must come to a complete stop before proceeding into or across the intersections where stop signs are designated.

(1) That North Main Street be, and is hereby declared to be a through street from the north line of Division Street to the north corporate limits, and the stop signs be, and are hereby established on the following intersecting streets where they intersect said North Main Street, viz: on East and West Washington Avenue, on East and West Adams Avenue, on East and West Jefferson Avenue, on East and West Madison Avenue, on East and West Monroe Avenue, on West John Adams Avenue, and on East and West Jackson Avenue.

(2) That stop signs be, and they are hereby established on North Main Street where it intersects Monroe Street, from the north and south

(3) That South Main Street be, and is hereby declared to be a through street from the south line of Division Street to the north line of U.S. Route Number 40 and that stop signs be, and are hereby established on the following intersecting streets where they intersect said South Main Street, viz: on East and West Lincoln Avenue, on East and West Johnson Avenue, on East and West Grant Avenue, and on West Hayes Avenue.

(4) That stop signs be, and they are hereby established on South Main Street at its intersection with U.S. Route Number 40.

(5) That stop signs, be and they are hereby established on North Main Street and South Main Street where they intersect Division Street.

(6) That stop signs, be and they are hereby established on East Division Street and West Division Street where they intersect Main Street.

(7) That stop signs, be and they are hereby established on North Second Street on both sides of West Washington Avenue where it intersects said North Second Street.

(8) That stop signs, be and they are hereby established on West Adams Avenue on both sides of North Second Street where it intersects said West Adams Street.

(9) That stop signs, be and they are hereby established on North Second Street on both sides of West Madison Avenue where it intersects said North Second Street.

(10) That stop signs, be and they are hereby established on North Second Street on both sides of West Monroe Avenue where it intersects said North Second Street.

(11) That stop signs, be and they are hereby established on West Monroe Street on both sides of North Second Street where it intersects said North Second Street.

(12) That North Third Street be, and is hereby declared to be a through street from the north line of West Division Street to the south line of West Monroe Street, and that stop signs be, and are hereby established of the following intersecting streets where they intersect said North Third Street, viz: on West Washington Avenue on each side of said North Third Street, on West Adams Avenue on each side of said North Third Street, and on West Madison Avenue on each side of said North Third Street.

(13) That stop signs, be and they are hereby established on West Division Street at its intersection with Third Street on each side.

(14) That stop signs, be and they are hereby established on North Third Street at its intersection with West Monroe Avenue on each side of said West Monroe Avenue.

(15) That stop signs, be and they are hereby established on South Third Street at its intersection with U.S. Route Number 40.

(16) That stop signs, be and they are hereby established on North Fourth Street at its intersection with West Division Street on each side.

(17) That South Fourth Street be, and is hereby declared to be a through street from the south line of West Division Street to the north line of U.S. Route Number 40, and that stop signs be, and are hereby established on the following intersecting street where it intersects said South Fourth Street, viz: on West Grant Avenue on either side of said South Fourth Street.

(18) That stop signs, be and they are hereby established on South Fourth Street at its intersection with U.S. Route Number 40.

(19) That stop signs, be and they are hereby established on South Sixth Street on both sides of West Division Street where it intersects North and South Sixth Streets.

(20) That a stop sign, be and is hereby established on South Sixth Street where it intersects Grant Avenue.

(21) That a stop sign, be and is hereby established on South Sixth Street where it intersects U.S. Route Number 40.

(22) That stop signs, be and they are hereby established on South Eighth Street where it intersects West Grant Avenue.

(23) That stop signs, be and they are hereby established on South Eighth Street where it intersects U.S. Route Number 40.

(24) That North Tenth Street be, and is hereby declared to be a through street from the north corporation limits of the City of Altamont to the north line of U.S. Route Number 40 and that a stop sign be, and hereby established on South Tenth Street at its intersection with U.S. Route Number 40.

(25) All vehicles on West Jefferson Avenue approaching North Tenth Street from the east shall observe the stop sign where West Jefferson Avenue intersects North Tenth Street.

(26) All vehicles on West Monroe Avenue approaching North Tenth Street from the east shall observe the stop sign where West Monroe Avenue intersects North Tenth Street.

(27) All vehicles on West Jackson Avenue approaching North Tenth Street from the east and west shall observe the stop sign where West Jackson Avenue intersects North Tenth Street.

(28) All vehicles on West Division approaching North Tenth Street from the east shall observe the stop sign where West Division Street intersects North Tenth Street.

(29) All vehicles on Carella Drive in Marten Heights Subdivision shall observe the stop signs on the north and south loop. Carella Drive intersects South Tenth Street on the north and south of said Marten Heights Subdivision.

(30) All vehicles on West Grant Avenue approaching South Tenth Street from the east shall observe the stop sign where West Grant Avenue intersects South Tenth Street.

(31) All vehicles on West Hayes Avenue approaching South Tenth Street from the east shall observe the stop signs where West Hayes Avenue intersects South Tenth Street.

(32) All vehicles on West Garfield Avenue approaching South Tenth Street from the east shall observe the stop sign where West Garfield Avenue intersects South Tenth Street.

(33) That stop signs be, and are hereby established on North St. Clair Street and South St. Clair Street where they intersect East Division Street.

(34) That stop signs be, and are hereby established on East Division Street at its intersection with Edwards Street.

(35) That stop signs be, and are hereby established on North Edwards Street and South Edwards Street where they intersect East Division Street.

(36) That stop signs be, and are hereby established on East Lincoln Avenue on both sides of South Edwards Street where it intersects said East Lincoln Avenue.

(37) That stop signs be, and are hereby established on East Johnson Avenue on both sides of South Edwards Street where it intersects said East Johnson Avenue.

(38) That stop signs be, and are hereby established on East Grant Avenue at its intersection with South Edwards Street.

(39) That stop signs be, and are hereby established on South Edwards Street at its intersection with U.S. Route Number 40.

(40) That stop signs be, and are hereby established on South Bond Street and on North Bond Street at their intersection with East Division Street.

(41) That stop signs be, and are hereby established on South Bond Street at its intersection with U.S. Route Number 40.

(42) That stop signs be, and are hereby established on Ewing Street where it intersects East Division Street.

(43) That stop signs be, and are hereby established on Ewing Street where it intersects U.S. Route Number 40.

(44) That stop signs be, and are hereby established on Coles Street where it intersects East Division Street.

(45) That stop signs be, and are hereby established on Coles Street where it intersects U.S. Route Number 40.

(46) That stop signs be, and are hereby established on Reynolds Street where it intersects East Division Street.

(47) That stop signs be, and are hereby established on Reynolds Street where it intersects U.S. Route Number 40.

(48) That stop signs be, and are hereby established on East Meadows Drive where it intersects East Division Street.

(49) That stop signs be, and are hereby established on East Meadows Lane where it intersects East Division Street.

(50) That stop signs be, and are hereby established on Whitler Drive where it intersects East Division Street.

(51) That stop signs be, and are hereby established on Ash Street where it intersects with Illinois Route Number 128.

(52) That stop signs be, and are hereby established on Oak Street where it intersects with Illinois Route Number 128.

(53) That stop signs be, and are hereby established on Fairlane Circle North where it intersects with Illinois Route Number 128.

(54) That stop signs be, and are hereby established on Frontage Road where it intersects with Illinois Route Number 128.

(55) That stop signs be, and are hereby established at the exit point road of Gilbert Park where it intersects with Illinois Route Number 40.

(56) That stop signs be, and are hereby established at the west end of the alley north of Mid Illinois Bank & Trust between North Second Street and North Third Street, entering North Third Street.

(57) All vehicles on East Lincoln Avenue approaching Ewing Street from the west shall observe the stop sign where East Lincoln Avenue intersects Ewing Street.

(58) All vehicles on East Johnson Avenue approaching Ewing Street from the west shall observe the stop sign where East Johnson Avenue intersects Ewing Street.

(59) That stop signs be, and are hereby established on West Jefferson Avenue on both sides of North Second Street where it intersects West Jefferson.

(60) That a stop sign be and is hereby established on Carriage Lane where it intersects Frontage Road.

(61) That a stop sign be and is hereby established on Jays Way where it intersects Main Street

(62) That a stop sign be and is hereby established on Do It Drive where it intersects with County Highway 25.

(63) That a stop sign be and is hereby established on Sadie Lane where it intersects with Main Street.

(64) All vehicles on Park Place approaching South Edwards Street from the west shall observe the stop sign where Park Place intersects South Edwards Street.

(65) All vehicles on Oak Street approaching South Edwards Street from the west shall observe the stop sign where Oak Street intersects South Edwards Street.

(66) All vehicles on Ash Street approaching South Edwards Street from the west shall observe the stop sign where Ash Street intersects South Edwards Street.

(67) All vehicles on Grove Street approaching South Edwards Street from the east and west shall observe the stop sign where Grove Street intersects South Edwards Street.

(68) That a stop sign be and is hereby established on Lincoln Drive where it intersects with Fairlane Circle.

(69) All vehicles on West Grant Street approaching South Third Street from the east and west shall observe the stop sign where West Grant Street intersects South Third Street.

(70) That a stop sign be and is hereby established on Horschu Drive where it intersects with North Tenth Street.

(71) That a stop sign be and is hereby established on East Wurl Lane where it intersects with Illinois Route 128.

(72) That a stop sign be and is hereby established on LaJean Drive where it intersects with Illinois Route 128.

(73) That a stop sign be and is hereby established on South St. Clair where is intersects with East Grant Avenue.

(74) That a stop sign be and is hereby established on Lake Drive where it intersects with East Meadows Lane.

SECTION II: THROUGH STREETS AND YIELD SIGNS: All vehicles driven upon the following named streets must yield the right-of-way before proceeding into or access the named intersections:

(1) All vehicles on North Second Street approaching North Main Street from the north, shall yield the right-of-way to all traffic on north Main Street.

(2) All vehicles on North Second Street approaching West Jackson Avenue from the south, shall observe the yield sign at North Second and shall yield the right-of-way to all traffic on West Jackson Avenue.

(3) All vehicles on North Third Street approaching West Jackson Avenue from the south, shall observe the yield sign at West Jackson Avenue and shall yield the right-of-way to all traffic on West Jackson Avenue.

(4) That South Third Street be, and is hereby declared to be a through street from the south line of West Division Street to the north line of U.S. Route Number 40, and that yield signs are hereby established on the following intersecting streets where they intersect said South Third Street, viz: on West Lincoln Avenue on each side of South Third Street, on West Johnson Avenue on each side of South Third Street, on West Grant Avenue on each side of South Third Street and on Hayes Avenue on each side of South Third Street.

(5) All vehicles on West Lincoln Avenue approaching South Fourth Street, from the east, shall observe the yield sign and yield the right-of-way to all traffic on South Fourth Street.

(6) All vehicles on West Johnson Avenue approaching South Fourth Street, from the east, shall observe the yield sign and yield the right-of-way to all traffic on South Fourth Street.

(7) All vehicles on West Hayes Avenue approaching South Fourth Street from the east shall observe the yield sign and yield the right-of-way to all traffic on South Fourth Street.

(8) All vehicles on North Seventh Street approaching West Monroe Avenue, either from the north or south, shall observe the yield sign and yield the right-of-way to all traffic on West Monroe Avenue.

(9) All vehicles on North Seventh Street approaching West Jackson Avenue, from the south, shall observe the yield sign and and yield the right-of-way to all traffic on West Jackson Avenue.

(10) All vehicles on North Seventh Street approaching West Jefferson Avenue from the North shall yield the right-of-way to all traffic on West Jefferson Avenue

(11) All vehicles on North Eighth Street approaching West Monroe Avenue, either from the north or south, shall observe the yield sign and yield the right of way to all traffic on West Monroe Avenue.

(12) All vehicles on North Eighth Street approaching West Jackson Avenue, from the south, shall observe the yield sign and yield the right-of-way to all traffic on West Jackson Avenue.

(13) All vehicles on North Eighth Street approaching West Jefferson Avenue either from the North or South shall yield the right-of-way to all traffic on West Jefferson Avenue.

(14) All vehicles on North Ninth Street approaching West Monroe Avenue, either from the north or south, shall observe the yield sign and yield the right-of-way to all traffic on West Monroe Avenue.

(15) All vehicles on North Ninth Street approaching West Jackson Avenue from the south, shall observe the yield sign and yield the right-of-way to all traffic on West Jackson Avenue.

(16) All vehicles on South St Clair Street approaching East Lincoln Avenue, either from the north or south, shall observe the yield sign and yield the right-of-way to all traffic on East Lincoln Avenue.

(17) All vehicles on South St. Clair Street approaching East Johnson Avenue from the north or south, shall yield right-of-way to all traffic on East Johnson Avenue.

(18) All vehicles on North St Clair Street approaching East Washington Avenue, either from the north or south, shall observe the yield sign and yield the right-of-way to all traffic on East Washington Avenue.

(19) All vehicles on North St Clair Street approaching East Jackson Avenue from the south shall observe the yield sign and yield the right-of-way to all traffic on East Jackson Avenue.

(20) All vehicles on North St Clair Street approaching East Monroe Avenue from the North or South shall yield right-of-way to all traffic on East Monroe Avenue.

(21) All vehicles on North St Clair Street approaching East Madison Avenue from the North or South shall yield right-of-way to all traffic on East Madison Avenue

(22) All vehicles on North St Clair Street approaching East Adams Street from the South shall yield right-of-way to all traffic on East Adams Street.

(23) That North Edwards Street be, and is hereby declared to be a through street from the north line of East Division Street to the south line of the Conrail right-of-way and from the south line of East Madison Avenue to the south line of East Jackson Avenue, and that yield signs are hereby established on the following intersecting streets where they intersect said North Edwards Street, viz: on East Washington Avenue on each side of North Edwards Street, on East Madison Avenue on each side on North Edwards Street, on East Monroe Street on each side of North Edwards Street.

(24) All vehicles on North Edwards Street approaching East Jackson Avenue from the south, shall observe the yield sign and yield the right-of-way to all traffic on East Jackson Avenue.

(25) All vehicles on South Bond Street approaching East Lincoln Avenue from either the north or south, shall observe the yield sign and yield the right-of-way to all traffic on East Lincoln Avenue.

(26) All vehicles on Coles Street approaching East Lincoln Avenue from either the north or south, shall observe the yield sign and yield the right-of-way to all traffic on East Lincoln Avenue.

(27) All vehicles on Reynolds Street approaching East Lincoln Avenue from either the north or south, shall observe the yield sign and yield the right-of-way to all traffic on East Lincoln Avenue.

(28) All vehicles on South Bond Street approaching East Johnson Avenue from either the north or south, shall observe the yield sign and yield the right-of-way to all traffic on East Johnson Avenue.

(29) All vehicles on Cole Street approaching East Johnson Avenue from either the north or south, shall observe the yield sign and yield the right-of-way to all traffic on East Johnson Avenue.

(30) All vehicles on Reynolds Street approaching East Johnson Avenue from either the north or south, shall observe the yield sign and yield the right-of-way to all traffic on East Johnson Avenue.

(31) All vehicles on Field Street approaching East Meadows Drive from the east, shall observe the yield sign and yield the right-of-way to all traffic on said East Meadows Drive.

(32) All vehicles on Prairie Street approaching East Meadows Drive from the east, shall observe the yield sign and yield the right-of-way to all traffic on said East Meadows Drive.

(33) All vehicles on Meadows Street approaching East Meadows Drive from the east, shall observe the yield sign and yield the right-of-way to all traffic on said East Meadows Drive.

(34) All vehicles on Prairie Street approaching East Meadows Lane from the west, shall observe the yield sign and yield the right-of-way to all traffic on said East Meadows Lane.

(35) All vehicles on Meadows Street approaching East Meadows Lane from the west, shall observe the yield sign and yield the right-of-way to all traffic on said East Meadows Lane.

(36) All vehicles traveling north on North Edwards Street shall observe the yield sign at the intersection of East Adams Street and North Edwards Street.

(37) All vehicles on Second Street approaching John Adams Street from the North or South shall yield right-of-way to all traffic on John Adams Street.

(38) All vehicles on Eighth Street approaching Madison Street from the North or South shall yield right-of-way to all traffic on Madison Street.

(39) All vehicles on Andeline Lane approaching North Tenth Street shall yield rightof-way to all traffic on Tenth Street

(40) All vehicles on Carriage Lane approaching Lincoln Drive from the East shall yield right-of-way to all traffic on Lincoln Drive

(41) All vehicles on Sherman Drive approaching Fairlane Circle shall yield the rightof-way to all traffic on Fairlane Circle

(42) All vehicles on Wurl Lane approaching South Edwards Street shall yield the right-of-way to all traffic on South Edwards Street.

(43) All vehicles on South Edwards Street approaching the intersection of South Edwards and Evergreen Street from the East shall yield the right-of-way to all North and South bound traffic on Evergreen Street and Edwards Street.

(44) All vehicles on Pine Lane approaching Evergreen Street shall yield the right-ofway to all traffic on Evergreen Street.

(45) All vehicles on Wacker Drive approaching Fairlane Circle shall yield the right-ofway to all traffic on Fairlane Circle.

(46) All vehicles on Wacker Drive approaching Lincoln Drive shall yield the right-ofway to all traffic on Lincoln Drive.

(47) All vehicles on West Hayes Avenue approaching South Eighth Street shall yield the right-of-way to all traffic on South Eighth Street.

(48) All vehicles on West John Adams approaching North Third Street shall yield the right-of-way to all traffic on North Third Street.

(49) All vehicles on West Elm Street approaching North Seventh Street, either from the east or west, shall yield the right-of-way to all traffic on North Seventh Street.

(50) All vehicles on West Elm Street approaching North Eighth Street, either from the east or west, shall yield the right-of-way to all traffic on North Eighth Street.

(51) All vehicles on West Elm Street approaching North Ninth Street shall yield the right-of-way to all traffic on North Ninth Street.

(52) All vehicles on West Lucky Drive approaching North Eighth Street shall yield the right-of-way to all traffic on North Eighth Street.

(53) All vehicles on West Lucky Drive approaching North Ninth Street shall yield the right-of-way to all traffic on North Ninth Street.

(54) All vehicles on North Seventh Street approaching West Madison Avenue, either from the north or south, shall yield the right-of-way to all traffic on West Madison Avenue.

(55) All vehicles on West John Adams approaching North Seventh Street, either from the east or west, shall yield the right-of-way to all traffic on North Seventh Street.

(56) All vehicles on West John Adams approaching North Eighth Street, either from the east or west, shall yield the right-of-way to all traffic on North Eighth Street.

(57) All vehicles on West John Adams approaching North Ninth Street shall yield the right-of-way to all traffic on North Ninth Street.

(58) All vehicles on LaJean Drive approaching Aker Drive shall yield the right-of-way to all traffic on Aker Drive

SECTION III: THROUGH STREETS AND NO PARKING SIGNS: All vehicles driven upon the following named streets shall observe the no parking signs designated where parking is prohibited.

(1) That a no parking sign is hereby established on the west side of North Second Street, directly south of West Adams Street.

(2) That a no parking sign is hereby established on the south side of West Adams Street, west of the intersection with North Second Street.

(3) That a no parking sign is hereby established on the north side of West Adams Street west of the intersection with North Second Street.

(4) That a no parking sign is hereby established on the north side of West Division Street, west 50 feet of the intersection with Main Street.

(5) That a no parking sign is hereby established on the north side of Madison Street, west of the Intersection with North Main Street through Ninth Street intersection.

(6) That a no parking sign is hereby established on the south side of Division Street, east 120 feet of the intersection with Main Street.

(7) That a no parking sign is hereby established on the south side of Madison Street, west of the intersection with North Main Street through Second Street intersection.

SECTION IV: ALLEYS AND ONE-WAY SIGNS: All vehicles driven in the following alleys shall observe the one-way signs designated where through traffic is prohibited.

(1) The alley north of Mid Illinois Bank & Trust will be one-way west between North Second Street and North Third Street.

SECTION V: UNLOADING ZONE IS ESTABLISHED: All vehicles shall observe the unloading zone and parking is prohibited sign.

(1) That an unloading zone is hereby established on the south side of West Adams Street, west of the intersection of North Third Street and Adams.

SECTION VI: This Ordinance replaces Ordinance No. 340 dated March 12, 2001 establishing Stop Sign, Yield Signs, No Parking Signs, Through Streets, One-Way Streets and Unloading Zone within the corporate limits of the City of Altamont, Effingham County, Illinois, and imposing penalties for violation thereof.

SECTION VII: PENALTY: Any person who shall violate any of the provisions of this Ordinance or fail to comply therewith shall be fined not more than five hundred dollars (\$500.00) for each offense.

SECTION VIII: EFFECTIVE DATE: This Ordinance shall take effect and be in force ten (10) days from and after its passage, approval, and publication as provided by law.
