ORDINANCE NO. 540-13

AN ORDINANCE AMENDING  
REVISED CODE OF ORDINANCES, CHAPTER 30 SECTION 2-29

CITY OF ALTAMONT, ILLINOIS

PATROL OFFICERS AGE AND CHARACTER

**WHEREAS**, pursuant to Altamont Revised Code of Ordinances, Chapter 30, Section 2-29 stating requirements of regular, full-time Patrol Officers employed by the City of Altamont and,

**WHEREAS**, said section conflicts with the City of Altamont Personnel Manual approved by the City Council on March 28, 2011 and,

**WHEREAS**, after careful consideration, the City Council of the City of Altamont, Illinois, has determined residency should not be a requirement of the City of Altamont patrol officers.

**NOW THEREFORE, BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALTAMONT, EFFINGHAM COUNTY, ILLINOIS THAT:**

Section 1. Chapter 30, Section 2-29 of the City of Altamont Revised Code of Ordinances is hereby amended as follows:

AGE AND CHARACTER. No person shall be appointed to or retained in the position of a regular, full-time Patrol Officer who is under **twenty-one (21) years** of age nor unless he is of good moral character.
