City of Altamont

The City of Altamont is a municipality incorporated, organized under the laws of the State of Illinois and operated under a commission form of government. The City Council is comprised of the Mayor and four Commissioners who are elected for four-year terms. The City Clerk, the City Treasurer, and the Department Supervisors are all appointed with the consent of the City Council.

The City Council meets formally on the 2nd and 4th Monday of each month at 6:00 p.m. The Mayor and each Commissioner is responsible for administering the functions of a certain department(s). The departments are: Water, Sewer, Park, Street & Alley, Police, Electric and Cemetery.

There are currently 21 full time and 6 part time and seasonal employees. The City Council has a proposed operating budget of \$11,172,875 (FY 2013-2014) The population of the City is 2283.

Any person requesting records of the City of Altamont must first obtain and complete a “Freedom of Information Request Form” from the City Clerk’s Office. All requests are to be submitted to the office of the City Clerk, at the address indicated on the front of this leaflet.

Records and information will be made available for inspection and copying unless the records of information are exempt under the Freedom of Information Act.

Each request will be complied with or denied within seven working days after its receipt. The seven day period may be extended up to fourteen working days if required. A copy of Freedom of Information Act is available upon request in the City Clerk’s Office.
